## <u>Acceptable use Policy – Parents</u>

- I understand that members of the school's staff can check my ward's computer files and the Internet sites that they visit if they have concerns about their online safety.
- I will support the school by promoting safe and polite use of the Internet and digital technology at home and will inform the school if I have any concerns over my ward's online safety or online behaviour.
- I understand that Our Own English High School, Sharjah (Girls) has a zero-tolerance policy with regard to cyber-bullying which applies both in and out of school. All incidents will be dealt with on a case by case basis in line with the school's Online safety, Anti-bullying and Child Protection policies. I understand that in some cases cyber-bullying may constitute a criminal offence under the laws of the region and that in certain cases OOS may seek the involvement of the police or other outside agencies as appropriate.
